#### SPONSOR SUPPORTING EVIDENCE

  - 1. Date and nature of employment
  - 2. Salary paid
  - 3. Whether the position is temporary or permanent
- D. If self-employed:
  - 1. Copy of last income tax return filed or
  - 2. Report of commercial rating concern
  - 3. Schedule of assets with supporting documents
