#### Introduction

During 2009-2010, the Library continued to be very busy and active, providing a multitude of services as outlined below. The transformation and revitalization of the Library continued, with improvements to its physical appearance, as well as an infusion of new books to its collections, and several new electronic databases.

#### I. Reference Services

(Statistics compiled by Prof. Di Su, Head of Reference Services, and Prof. John Drobnicki, Chief Librarian)

The Library Faculty handled 24,815 questions during the 2009-2010 academic year (July 2009 to June 2010), reflecting a slight decrease over the previous year's total of 25,915 questions.

The types of questions that the Library Faculty are handling has also changed, with many more "non-professional" questions being asked, especially over the past six academic years. This is likely a direct result of the OCS copying/printing system, which places a high customer service burden on the librarians on duty at the reference desks, whom students must turn to when they have problems with the system and/or forget their username/PIN.

#### **II.** Acquisitions & Collection Development

(Statistics provided by Prof. Njoki-Wa-Kinyatti, Coordinator of Collection Development)

Thanks to support from the York College Administration, the Library had a healthy budget for the fourth consecutive year. The budget was also supplemented with \$66,500.00 from CUNY Central as part of the Chancellor's Student Textbook Initiative, to be spent on Reserve textbooks – these textbooks were purchased from both our book vendor (COUTTS) and from the campus Barnes & Noble bookstore.

The 2005 Agreement between CUNY and the New York City Department of Education provides \$60 per high school student to the Library on a CUNY campus with an affiliated high school. Since the York Library serves the students of an affiliated DOE high school (the Queens High School for the Sciences at York College), the York Library received \$24,900.00 in High School funds during 2009-2010. These funds were spent solely on books. Since the High School funds are not New York State tax-levy funds, they have not been included in Table 2 – nor have the funds the Library received from the Student Technology Fee (see Section V below).

#### **III.** Cataloging & Collection Maintenance

(Data provided by Mrs. Rose Dunne, CUNY Administrative Assistant, Cataloging)

From July 1, 2009 to June 30, 2010, a total of 3,428 volumes were added to the Library's collections, which included 474 volumes for the Reference Collection; 2,551 volumes for the Circulating Collection; and 403 titles for the Reserve Textbook Collection. Also, 2 DVDs were added to the collection. During the past year, 2,294 books were withdrawn from the Library's collections.

#### **IV. Circulation & Reserve**

(Statistics provided by Mrs. Grace Avila, Manager of Circulation & Reserve)

The Library continues to be very busy, with students borrowing both Reserve materials (for in-Library use) and Circulating materials (to take home). Table 3: Number of Circulation/Reserve Transactions, July 2007-June 2010

#### V. Electronic Resources

(Data provided by Ms. Anamika Dasgupta, Coordinator of Electronic Resources & Library Webmaster)

The Library received \$181,800 in funding from the Student Technology Fee during the 2009-2010 academic year. The Library would not be able to subscribe to many of our electronic resources without the financial support we receive from the Tech Fee. If the Library had to pay for reference databases from OTPS funds, the consequence would be that we would not be able to order any books. (Tech Fee funds were also used to buy toner and paper for the student printers and photocopy machines in the Library, as well as to upgrade the photocopy machines.)

The Library added subscriptions to several important databases over the past academic year:

- Garland Encyclopedia of World Music Online
- Health Reference Center Academic
- Nursing & Allied Health Collection
- Wall Street Journal, 1984-Present

Through the initiative of Professor Glenn Lewis (Director of the Journalism Program) and the generosity of SAGE Publications, the Library received permanent online access to the electronic version of the *Encyclopedia of Journalism*.

Thanks to the CUNY Central Office of Library Services, five new electronic products were also made available to all CUNY libraries over the past year, at no cost to the individual libraries:

#### VI. Computers/Technology

(Data provided by Mr. Daniel Cleary, Science Librarian and Liaison to IT Department)

With Tech Fee funds, the Library purchased five new Ricoh photocopy machines, one of which

is currently being used as a scanner, and two of which will allow color copying/printing. Staff from the IT Department are working with both OCS (our print management system) and Ricoh to fix an issue that will enable us to charge differential pricing (i.e., charge more for color copies). With the scanner, students are able to scan documents and send them to their York email accounts. The IT Department is pursuing the ability to scan to network storage accounts, as well as to give faculty the ability to log into the Ricoh copiers and scanner.

All of the computers from the H-wing have been moved to the G-wing, and new network ports have been installed to accommodate 20 new Macs that will be purchased for the Library by IT. The Library paid for new Cisco network switches to be installed to handle the additional computers on the G-wing.

#### **VII. Information Literacy**

(Statistics compiled by Prof. Scott Sheidlower, Coordinator of Information Literacy)

The Library continued to have a very active Information Literacy program, which is frequently publicized on Yorktalk by Prof. Sheidlower. All of the Library Faculty taught IL sessions over the past year. Surprisingly, the demand for IL classes went down this year, as can be seen in the following table:

Unfortunately, the size of the Information Literacy classroom (3H-09) often limits the number of classes that Library Faculty can teach. The IL room has 18 computers (with usually a couple "out-of-order"), and therefore can only comfortably accommodate a maximum of about 20 students. Thus, Library Faculty taught a lot of sessions in the Classroom Building labs over the past year. It is hoped that a proposal to expand the IL room and improve the technology in the IL room will take place over the next year or two. The Library's IL room also continued to be used regularly by staff from Academic Computing/Educational Technology for their workshops, as well as by classroom faculty who wanted to make use of the smartboard and student computers for particular lessons.

#### VIII. Periodicals & Microforms

(Statistics provided by Prof. Hope Young, Head of Serials, Microforms, and Interlibrary Loan)

As the full-text of more periodicals has become available in the Library's electronic databases, the usage of printed periodicals and microforms has dropped off over the past few years. But

there are still numerous important journals, particularly in Occupational Therapy and Social Work, which are *not* available online and which must be accessed in either print or microfilm. Thus, the Periodicals & Microforms Collections still get regular use, as shown in the following tables:

#### IX. Interlibrary Loan

(Statistics provided by Prof. Hope Young, Head of Serials, Microforms, and Interlibrary Loan)

With the advent of the CLICS service, users can now easily and quickly request books from other CUNY libraries by simply clicking on a link within the CUNY+ Online Catalog. This has led to a decline in the number of books that students request through Interlibrary Loan (ILL), since most books that students need are found within the CUNY library system. Faculty, however, are engaged in deeper research, and continue to request books that must be borrowed from outside the CUNY library system. Since CLICS is only for books, there is still heavy use of ILL to obtain copies of journal articles. Two years ago (2007-2008), there were 401 ILL requests from York to other libraries; last year (2008-2009) there were 525; while this year (2009-2010) there were 506.

The Library has recently begun to use ILLiad, a patron-initiated online ILL system, generously paid for by the CUNY Central Office of Library Services. It is being piloted with faculty from three academic departments.

### X. CLICS

(Statistics provided by Mrs. Grace Avila, Manager of Circulation & Reserve)

CLICS (CUNY Libraries Inter-Campus Services) is a book delivery service that lets users request books from any CUNY library to be delivered to any other CUNY library. Of course, York Library patrons almost always request their books to be sent to the York Library. Although the patron initiates the request by clicking on a link in the CUNY+ Online Catalog, there is still much staff time involved, on both ends of the transaction. The lending library has to send someone to find the book on the shelf; it must be scanned in the Aleph system; it must be packed in a blue LAND bag; it is then picked up by a courier and delivered to the borrowing library, where it must be opened, scanned, and held for pick up. Although the Aleph system is supposed to send an automated email message to the borrower, the York Library Circulation staff sends a direct email as a back-up, and in the case of Faculty or Staff, calls the patron to let them know their item has arrived.

# XI. Outreach to Queens High School for the Sciences at York College (QHSSYC) and York Early College Academy (YECA)

(Data provided by Ms. Christina Miller, School Library Media Specialist)

During July 2009, Christina Miller conducted 18 Information Literacy sessions as part of the YECA Summer Immersion Program. During the academic year, Ms. Miller conducted 30 Information Literacy sessions for QHSSYC students. With assistance from Sandra Urban, Ms. Miller also arranged and taught a two-hour Literary Criticism Workshop for the AP English class from the Queens High School for Law Enforcement and Public Safety (Mar. 2010). As it has done every year since the 3-day event's inception, the York Library hosted QHSSYC's 8th Annual Science Poster Presentation.

# **XII.** Facilities/Exhibits

As a result of a Spring 2009 report from space consultant Jay Lucker, as well as the College's pressing space shortage, the Library has been moving out of the 3rd floor H-wing over the past year. This involved extensive weeding of the Reference Collection and the print Periodicals Collection, and the physical moving of reference books, bound periodicals, microfilm, and offices. The project could not have been accomplished without the leadership, cooperation, and hard work of Mr. Daniel Cleary, Professor Hope Young, Ms. Jennefer Clarke, Ms. Toni McMillan, and several College Assistants (Julia Myers, Samantha Rossi, and Ria Hutson). We are similarly indebted to Mr. George Fellows and the staff of Buildings & Grounds, who devoted much time and manpower to the Library's physical reorganization.

UV-protective film was installed on the interiors of the Library's 2nd and 3rd floor windows by an outside vendor, Sunshield Energy Control Systems. Aside from the environmental benefits of filtering out heat and UV rays, it also enabled us to discard the circa-1986 curtains, resulting in a more open appearance.

In addition to displays of new books which rotate regularly, Christina Miller also maintained a year-long book display to highlight the NEH *We the People* "Picturing America" bookshelf collection. The Library also hosted two exhibits over the past year which were curated by Ms. Miller: the Fall exhibit consisted of artworks in ink, marker, and wax rubbing on paper and wood by Mary Hatch; and the Spring exhibit contained artworks rendered on paper in graphite, colored pencil, and silverpoint by Rosalie Orlando Hatch. The Library continues to display books written (or edited) by York faculty members, both current and historical, as part of the Faculty Book Display.

# XIII. Library Staff

During the Summer of 2009, the Library welcomed Mr. Travis Hilton as a full-time CUNY Office Assistant, after several years of working as a College Assistant. We also hosted an intern, Mr. Yen-Huang (Joe) Lee, from the Queens College Graduate School of Library and Information

Studies. Joe was our first GSLIS intern in more than a decade.

#### XVI. Library Goals and Objectives for 2010-2011

Needless to say, the Library plans to continue providing high quality instruction and support to

students and faculty to meet their research needs. In addition, there are several specific goals for the coming year.

As mentioned above (Section XII), the Library Faculty and Staff worked very hard over the past year moving H-wing services onto the G-wing. During the 2010-2011 academic year, we will work to fully integrate the former H-wing services and personnel into G-wing operations. We will also update and/or create signage to reflect the changes in the floor plan.

The Library will continue to participate in the Records Retention Project, disposing of duplicate records and materials that have been accumulated over the past 40 years.

The renovation of Circulation/Reserve is scheduled to take place during 2010-2011, according to the Office of Campus Planning. Under the leadership of Mrs. Grace Avila, the Library will work hard to make sure that any construction (and/or de-construction) causes minimal disruption to Circulation and Reserve operations, and therefore hopefully minimal negative impact on Library users.

The Library will improve its outreach to the Faculty through our Liaison program, with the goal of making Faculty more aware of Library resources and services.

Young Adult materials that are classified and shelved in the Library's main collection will be reclassified and moved to the Curriculum Materials/Young Adult Collection.

The Library will undertake an Academic Program Review during 2011-2012, and will begin to lay the groundwork during 2010-2011. Library Faculty had a preliminary meeting with Dr. Aghajan Mohammadi (Director of Institutional Research and Assessment) and Ms. Shao-Wei Wu (Coordinator of Assessment) during Spring 2010, and we anticipate working closely with them and their staff during 2010-2011 to design appropriate assessment instruments for Library services.

Classroom Faculty and students are encouraged to serve on the Senate's Library Committee, which provides input to the Administration and to the Library Chairperson on Library services. Thanks to the 2009-2010 Library Committee Chair, Prof. Njoki-Wa-Kinyatti (Associate Professor of Library Services), and the members who served during the past year, for their helpful advice and insight. We look forward to working with the members of the 2010-2011 Library Committee.

# What were the findings of your analysis?

The Library has collected data for decades on Reference questions, including by time-of-day and by day-of-the-week. During 2009-2010, the Library moved out of its H-wing space, consolidating Reference services on the G-wing. With only one Reference Desk on the G-wing starting in 2010-2011, the Head of Reference needed to decide which times of day necessitated the presence of two librarians on duty, and which times could have one. The Head of Reference examined the data for the past decade, which is included below:
