

Accreditation Update

Office of Institutional Effectiveness and Strategic Planning (OIESP)

York College is accredited by <u>the Middle States Commission on Higher Education (MSCHE)</u>. "The MSCHE is an institutional accreditor recognized by the United States Department of Education (USDE). As an institutional accreditor, MSCHE requires evaluation of all aspects of the institution holistically, including modality of instruction, and everything done in the name of the institution, including all academic programs and services, that fall within their scope of accreditation¹". This accreditation update aims to inform the community about the Commission's most recent action on January 16, 2025, which required York College to submit a **Supplemental Information Report (SIR)** focused on institutional six-year graduation rates by February 14, 2025 (later extended to February 26, 2025). It is important to note that the supplemental information report does <u>not</u> denote non-compliance. The College remains fully accredited. The following is an excerpt from the notification received in November:

For the 2024 collection year, the Commission has analyzed the results for student achievement and annual reporting – FTE. The data collected from your institution suggests concerns with the following:

Student Achievement: Graduation Rates calculated at the institutional level by credential level.
Four-Year Institution: The Graduation Rate at 150% of the normal time available through the most recent AIU report is below 40%.

Therefore, the **York College of the City University of New York** should respond to this request for information in a supplemental information report (SIR) by **February 14, 2025**, providing (1) graduation rates for the last two years (Standard IV) and (2) narrative analysis and evidence of the actions the institution has planned or has taken to address these concerns (Standard IV).

The SIR was submitted to the commission on **February 13, 2025** via the MSCHE Institutional Portal.

MSCHE Ongoing Monitoring and Evaluation Processes

MSCHE has ongoing monitoring and evaluation processes as defined in its Accreditation Review Cycle and Monitoring Policy. There is an eight-year cycle of evaluation that consists of a self-study report and an on-site evaluation visit focused on compliance with the seven standards and requirements of affiliations. In addition, monitoring activities consist of the Annual Institutional Update (AIU), follow-up reports and visits, and out-of-cycle monitoring activities. The AIU monitors student achievement, annual FTE enrollment, financial health, and federal financial responsibility; please visit the MSCHE website for more information. AIU completed each year provides the Commission with updates to key institutional characteristics (contacts, locations, Carnegie classification, etc.), student enrollment, financial, and "student success" metrics such as graduation rates. As a result of the last AIU submission in 2024 and the new MSCHE process, the Commission requested a Supplemental Information Report focused on the six-year graduation rate as it remains below the MSCHE-identified threshold of 40%. Please note, York's six-year graduation rate has never reached 40%; however, as a result of this new MSCHE process, the College has been asked to provide additional information on the actions that York has recently taken to address the graduation rates.

As requested by the Commission, the following table details six-year graduation rates for first-time, full-time students; while the Commission requested data for two years, we provided data for five years to demonstrate trends. While the graduation rates are below the MSCHE Annual Institutional Update threshold of 40%, the graduation rate has remained relatively stable over five years and hovers at 32% for the most recent cohort, an increase of 2 percentage points over the prior year.

Summary of York's SIR Submission

Within the context of York College's strategic plan, CUNY's Strategic Roadmap, and in compliance with MSCHE's strict guidelines, the SIR consisted of a 15-page narrative followed by appendices. Student Achievement data including the six-year graduation rates, analysis of student outcomes for cohorts entering 2014-2018, four-year graduation rates, one-semester and one-year retention rates, trends in performance in Gateway Math and English, completion of 30 credits or more were provided in the five-page introduction. A substantive narrative and analysis chapter discussed the recent initiatives undertaken to improve graduation rates. The table below highlights each of the initiatives described:

The report concluded with a summary of the initiatives and data suggesting that these initiatives are intended to improve the student experience and thus improve retention and graduation rates. In addition, the conclusion noted:

"York College diligently monitors, disaggregates, analyzes, and communicates student outcomes data, integrating it into its annual operational planning processes. Recent student achievement data indicates a modest improvement in York College's four-year graduation rates over time. Conversely, the six-year graduation rates have shown consistency, maintaining levels between 30% and 35% over the past five years. Demonstrating ongoing commitment, the College consistently identifies new initiatives and strategies aimed at supporting students from enrollment through graduation." (SIR 2025)
