4 President's Report (IP Eanes)

- Thank you at all senators
- Thanks to attendees of 3rd virtual Town Hall. Other Town Halls might be planned because they work well.
- Covid response team (members of the cabinet and others) formed to discuss how to transition to distance learning.
- April was bad...meaning of crisis: open and honest communication with each other, and teamwork.
- Observe a moment of silence for members of the community that we have lost. Memorial planned when we return in-person.
- Update from Chancellor/Presidents call: the State has been allowed to modify the budget 3 times during the next fiscal year (April 30, June 30, Dec 31, 2020); Hard budget year anticipated; Enrollment may reduce and that will impact the budget also; campus CARES act money (for the students) has not been distributed yet; Credit/No Credit resolution posted on the website; Faculty training will be offered this summer to help faculty prep for continued distance learning space; Staff training will also be available.
- Update regarding bursar holds and de-registration policies: In contact with AVP Perez as these impact revenue.
- Update on commencement: Commencement is postponed, not canceled. Students can get a refund for the cap/gown, if they choose; questions sent to student development for follow-up.
- Volunteer Emergency Student Success coaching Network mobilized (160 community members, faculty and staff) – to reach out to students to do wellness checks.
- Shout out to IT for a wonderful job giving out devices to the students to aid in distance learning.
- Update from CoS (Dana Trimboli) – some stop-n-go with campus facility projects to determine essential personnel; Active projects (ground water infiltration, thermostat repairs, PAC repairs continue, two ADA projects ongoing, lab space/lecture halls/faculty dining room reno projects under consideration, green house/HVAC improvement reno underway, roof projects underway). Wooden structures around escalators removed already.

➤ **Elections Committee (Prof. Larry Tung – Chair Elections Committee)**

-- New Rules for Electing Senators

- First time adjunct senator elections will be conducted.
- 2019 Charter, article 3, section 2, part D: Two adjunct (part-time faculty) can be elected as senators and must be currently active.
- Elections must be completed by May 10th (Sunday this year), so this has been moved to Friday, May 8th, 2020.
- The 2 part-time senators cannot be from the same dept.
- All part-time faculty teaching in Spr 2020 are eligible to vote and currently there are 484 active adjuncts.
- Nominations ended April 17th, 7 candidates self-nominated to enter the race.
- Voting will be done via Qualtrix between May 4th-8th
- For Full-time Faculty senators, the elections must also be between May 4th – 8th and a Blackboard site will be created to submit the report soon.
- Voting for SGA election is from May 9-15 and an outside vendor will conduct the SGA elections online.

➤ Counting Departmental Senators (Meleties) -- New Rules for Counting Number of Senators for Departments

- Revision of the Charter, these revisions implemented this academic year.
- Senators from departments proportional to number of full-time faculty members. Therefore depts with:
 - 0 – 10 full time faculty gets 1 senator
 - 11 – 20 full time faculty gets 2 senators
 - More than 20 faculty gets 3 senators
- Departmental elections need to take place in the first full week of May (May 1st – 8th).
- The change in the charter reduces the number of faculty senators (and matching number of student senators)

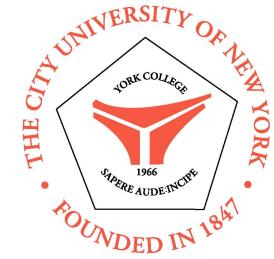

8 New Business

- Question from the floor: Are professors allowed to extend their classes into club hours, or are club hours excluded from having classes?
- Answer: Classes are asked to continue running at the normal times as best as possible.
- Question from the floor: Regarding student struggle for election candidacy and some student senators are not cleared to run do the effect of covid-19. An appeal has been sent but voting is two weeks away.
- Answer: Appeal received by IP Eanes and will be addressed in a timely manner.
- Question from the floor: Are students mandated to have their cameras on while they're in class?
- Answer: There is an ongoing discussion. This is an academic and FERPA issue so we cannot ask/mandate them to have their camera on. Use of Respondus tool triggered this discussion across CUNY. Need to discuss how to preserve the integrity of the courses without violating privacy. Testing program used by the Nursing department is not as intrusive and so that was proposed to CUNY early on but still awaiting unified decision...ongoing discussion.

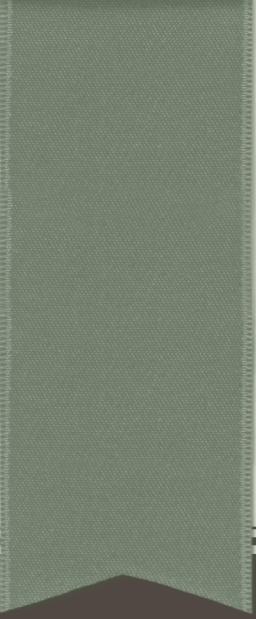

Governor's Executive Order No. 202.1

“...pursuant to the authority vested in me by Section 29-a of Article 2-B of the Executive Law to temporarily suspend or modify any statute, local law, ordinance, order, rule, or regulation, or parts thereof, of any agency during a State disaster emergency, if compliance with such statute, local law, ordinance, order, rule, or regulation would prevent, hinder, or delay action necessary to cope with the disaster emergency or if necessary to assist or aid in coping with such disaster, I hereby temporarily suspend or modify, for the period from the date of this Executive Order through April 11, 2020 the following:

... Article 7 of the Public Officers Law, to the extent necessary to permit any public body to meet and take such actions authorized by the law without permitting in public in-person access to meetings and authorizing such meetings to be held remotely by conference call or similar service, provided that the public has the ability to view or listen to such proceedings and that such meetings are recorded and later transcribed

Governor's Executive Order No. 202.14: Further extends the order to May 7, 2020.

Article 7, Section 102: Definitions

- Defines “Meeting” as “the official convening of a public body for the purpose of conducting public business, including the use of videoconferencing for attendance and participation by the members of the public body.”
- Defines “Public Body” as “any entity, for which a quorum is required in order to conduct public business and which consists of two or more members, performing a governmental function for the state or for an agency or department subcommittee or other similar body of such public body.”
- Defines “Executive Session” as “that portion of a meeting not open to the general public.”

Article 7, Section 103: Open Meetings and Executive Sessions

- 103(a): “Every meeting of a public body shall be open to the general public, except that an executive session of such body may be called and business transacted thereat in accordance with section one hundred five of this article.”
- 103(b): “Public bodies shall make or cause to be made all reasonable efforts to ensure that meetings are held in facilities that permit barrier-free physical access to the physically handicapped, as defined in subdivision five of section fifty of the public buildings law.”
- 103(c): “A public body that uses videoconferencing to conduct its meetings shall provide an opportunity for the public to attend, listen and observe at any site at which a member participates.”

Article 7, Section 103: Open Meetings and Executive Sessions

- 103(d): “Public bodies shall make or cause to be made all reasonable efforts to ensure that meetings are held in an appropriate facility which can adequately accommodate members of the public who wish to attend such meetings.”
- 103(d)(1): “Any meeting of a public body that is open to the public shall be open to being photographed, broadcast, webcast, or otherwise recorded and/or transmitted by audio or video means. As used herein the term “broadcast” shall also include the transmission of signals by cable.

Effect of Executive Orders on Section 103?

- Meetings may be held by conference call or similar mode
- Meetings must still be accessible by the public
- Meetings may still be recorded by anyone, and must be recorded by the organization
- A transcript of the meeting must be made available after the meeting

Article 7, Section 104: Public Notice

- 104(1): “Public notice of the time and place of a meeting scheduled at least one week prior thereto shall be given or electronically transmitted to the news media and shall be conspicuously posted in one or more designated public locations at least seventy-two hours before such meeting.”
- 104(4): “If videoconferencing is used to conduct a meeting, the public notice for the meeting shall inform the public that videoconferencing will be used, identify the locations for the meeting, and state that the public has the right to attend the meeting at any of the locations.”
- 104(5): “If a meeting will be streamed live over the internet, the public notice for the meeting shall inform the public of the internet address of the website streaming such meeting.”

Effect of Executive Orders on Section 104?

Other than lifting the requirement to provide notice of physical locations where meetings are taking place, the Executive Orders do not alter the requirement that prior notice be given to the public, with information as to how to access the meeting.

Because, under the Executive Orders, the meetings may take place by conference call, it follows that members of the public be allowed to participate in the conference call, and information about how to access be part of the public notice.

Article 7, Section 105: Conduct of Executive Sessions

- 105(1): “Upon a majority vote of its total membership, taken in an open meeting pursuant to a motion identifying the general area or areas of the subject or subjects to be considered, a public body may conduct an executive session for the below enumerated purposes only, provided, however, that no action by formal vote shall be taken to appropriate public moneys:
 - a. matters which will imperil the public safety if disclosed;
 - b. any matter which may disclose the identity of a law enforcement agent or informer;
 - c. information relating to current or future investigation or prosecution of a criminal offense which would imperil effective law enforcement if disclosed;
 - d. discussions regarding proposed, pending or current litigation;
 - e. collective negotiations pursuant to article fourteen of the civil service law;
 - f. the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation;
 - g. the preparation, grading or administration of examinations; and
 - h. the proposed acquisition, sale or lease of real property or the proposed acquisition of securities, or sale or exchange of securities held by such public body, but only when publicity would substantially affect the value thereof.

Effect of Executive Orders on Section 105?

There is no effect on Section 105 resulting from the Executive Orders, except that public bodies must find a way to conduct Executive Sessions private from public observers.

Article 7, Section 106: Minutes

- 106(1): “Minutes shall be taken at all open meetings of a public body which shall consist of a record or summary of all motions, proposals, resolutions and any other matter formally voted upon and the vote thereon.”
- 106(3): “Minutes of meetings of all public bodies shall be available to the public in accordance with the provisions of the freedom of information law within two weeks from the date of such meeting except that minutes taken pursuant to subdivision two hereof shall be available to the public within one week from the date of the executive session.”

Effect of Executive Orders on Section 106

There is no change in the requirements of Section 106 resulting from the Governor's Executive Orders.

Sample Cases

- Smith v. City University of New York, 685 N.Y.S.2d 910, 92 N.Y.2d 707 (NY 1999)
 - Fiorello H. LaGuardia Community College Association, Inc., is subject to the New York State Open Meetings Law.
 - Action brought by the student editor-in-chief of the student newspaper, the Bridge, and another journalist.
 - Plaintiffs had been barred from a meeting of the Association and the Dean of Student Affairs, which was conducted in private and resulted in restrictions being imposed on the Bridge.
 - This followed a period of suspension of the Bridge, after the Bridge published an article “containing offensive statements about Jews.”
 - “In our judgment, the Association, Inc. performs substantially more than a mere advisory function with respect to college activities and expenditures and, therefore, exercises a quintessentially governmental function. In determining whether an entity is a public body, various criteria or benchmarks are material. They include the authority under which the entity was created, the power distribution or sharing model under which it exists, the nature of its role, the power it possesses and under which it purports to act, and a realistic appraisal of its functional relationship to affected parties and constituencies.”
 - Key to the Court’s decision was the Association’s control over Student Activity Fees, deemed “public funds.”
 - The Court ordered that all future meetings of the Association comply with the Open Meetings Law, annulled actions taken as to the Bridge, and awarded attorney’s fees and costs.

Sample Cases

- Perez v. City University of New York, 840 N.E.2d 572, 5 N.Y.3d 522, 806 N.Y.S.2d 460 (NY 2005)
 - The Court held that the Hostos Community College Senate is subject to the New York State Open Meetings Law.
 - Action was brought by two students who had been denied access to a meeting of the Senate, although the Senate had not gone into Executive Session.
 - “While an entity must be authorized pursuant to state law to be within the ambit of the Open Meetings Law and the Freedom of Information Law, not every entity whose power is derived from state law is deemed to be performing a governmental function. Certainly not all advisory bodies that issue recommendations to state agencies are performing governmental functions for purposes of compliance with the Open Meetings Law. Rather, in each case the court must undertake an analysis that centers on ‘the authority under which the entity was created, the power distribution or sharing model under which it exists, the nature of its role, the power it possesses and under which it purports to act, and a realistic appraisal of its functional relationship to affected parties and constituencies.’” (Internal citations omitted.)
 - Held, the role of the Senate is more than advisory, in that, although the decisions of the Senate are subject to the approval of the President, that approval is “overwhelmingly” granted.

Course Description:

Cybersecurity is the state of being protected against the criminal or unauthorized use of electronic data, and the measures taken to achieve this goal. This course enables students to analyze realistic case scenarios and identify the depth and breadth of the cybersecurity challenge from multiple perspectives.

In this course, you will become “cyberinterns” and work in teams with course faculty, graduate assistants, and industry experts as mentors using an online/cloud communication platform known as iQ4. Students will focus on the interrelated dimensions of the threat (which may include but are not limited to technical, procedural, legal, behavioral, skills/proficiencies) and the spectrum of constituent cyber domains/functional areas in which to identify solutions. This is a three credit class.

Course Objectives:

Industry Motivation: Tackling Skills Shortages - Cybersecurity Financial Services and Healthcare firms report a significant shortage of graduates with the skills, experience and an understanding of financial markets and technologies, in critical infrastructure including Cybersecurity, Business Resiliency, IT Risk, Business Risk and Auditing. In response to these ‘skill-gaps’, iQ4 has launched the Cybersecurity Workforce Alliance (CWA) to meet present and future industry demand

for Cybersecurity talent, and producing graduates that are “workforce ready” ... our next-generation workforce.

Student Motivation:

Increased workforce readiness from a virtual-internship mentored by industry experts has proven that the CWA course increases the chances of physical internships and jobs. This is a 3-credit course. The content for the CWA challenge covers core competencies e.g., knowledge, skills, and abilities relating to the identification, detection, protection against, response to, and recovery from an insider threat including how to build and maintain communications with executives, peers and regulators. And essential skills (e.g., teamwork and communications skills), which are required in the workforce. The assignments of the virtual internship are designed to assess both core competencies and essential (soft/professional) skills.

Course Goals:

Utilizing the National Institute of Standards and Technology (NIST) Cybersecurity Framework, provide a mitigation and management strategy for the scenario provided, covering each of the following areas:

- Identify
- Detect
- Protect
- Respond
- Recover

Learning Outcomes

Upon completion of this course you will be able to:

Cybersecurity Skills

- Assess the current security landscape, including the nature of the threat, the general status of common vulnerabilities, and the likely consequences of security failures;
- Recognize and define insider threat as it applies to the financial sector

- Identify the constraints and decision criteria among elements that comprise a modern security system, including hardware, software, policies, and people.
- Identify alternative methodologies and actions
- Assess the role of strategy and policy in determining the success of information security;
- Evaluate the alternatives course of action in case of a breach
- Choose or formulate the best solution for a cyber-security breach
- Plan and undertake a group project, prepare and deliver coherent and structured verbal and written technical reports.

Communication experience

- Knowledge and practice in producing executive briefing material/memos;
- Knowledge and practice in producing Infographics;
- Knowledge and practice in producing succinct briefing videos on the current situation, the derived problems and implications and what actions are being taken to mitigate, respond or defend against future incidents;
- Presentation skills to a large audience of employers, mentors, academics/educators and government attendees at the “finals” (both individual role participation and the team based approach to the “Threat Within” challenge).

Intellectual Skills developed - the abilities required to process the subject matter

- Professionalism, critical thinking, problem solving, advocacy, communication, teamwork, written communications, verbal communications, innovation and creativity, confidence, composure, poise, coalition building, supervision, leadership, analytics, ability to pivot/change, decision making, contextual awareness, business writing skills (as opposed to academic writing).

Professional/practical skills – those skills specific to a subject area

- Contextual awareness and knowledge of Cyber security threat landscapes, actors and frameworks used by employers to protect, defend and respond to Cyber, risk and compliance challenges. Understanding of job roles within industry/employers and why they are needed and have different skill sets, yet are essential to form a composite capability.

Course Contact Hours

This course is offered in a hybrid-online format. Approximately 50% of the course will be conducted online through the iQ4 platform. The course meets in-person. Additionally, you will be meeting with your team both online and in-person for several hours each week to work through each assignment.

Assessment

Team Assignments

You will be working on a team consisting of 5 – 10 peers, each taking on one of the given role profiles (see “Project Role Profiles”). Once your team has been formed, you will have weekly deliverables in the form of documents, infographics, and videos, as well a weekly contribution to the mentored Q&A sessions. No later than 48 hours before each mentor session, you will be required to post your completed assignment, along with a 2-minute video overview of your work for that week to the iQ4 platform. Prior to the mentoring session, industry and faculty mentors will watch your video and review all documentation relevant for that week’s assignment. During the mentor session, you will be given feedback from the mentors and have the opportunity to ask questions and seek clarification for the current and future assignment. Mentors will provide guidance on how they would tackle the real-world assignments in their own organizations so that you have a framework to build on. Failure to submit an individual or team-based assignment element, e.g. executive report, Infographic or video will negatively impact your project grade for that week.

Individual Assignments

There will be approximately ten (10) individual “mini-assignments” given throughout the semester. These assignments simply verify that you have read and understand the main points from the assigned reading for each week. The format of the assignments will be short-answer. Completing these assignments should not take more than 15 – 20 minutes. Mini-assignments will be typed and submitted online through the iQ4 platform.

Participation

You are required to attend every mentor session, unless you have a documented excuse. Attendance will be taken at the beginning of the session. If you are profoundly late, you will be marked as absent.

Additionally, you are expected to contribute weekly to discussions and threads on the iQ4 platform. We will track the number of posts, responses, questions, etc. that you post to the platform. You are required to make at least one (1) significant contribution to a discussion each and every week.

Case Studies

The following four (4) case studies are provided to give you an understanding of the complexities involved with insider threats. Your team must pick one of the case studies to follow throughout the project.

Case Study 1: Fraud

A lead software developer at a prominent financial services firm devised a scheme by which he could earn fraudulent rewards points by linking his personal accounts to corporate business credit card accounts of third party companies. He cashed in the rewards points for gift cards and sold them in online auctions for cash. In all, he was able to accumulate approximately 46 million rewards points, \$300,000 of which he converted into cash.

Case Study 2: IT Sabotage

The firm employed a contractor as a night time security guard who was extensively involved with the cyber underground and the leader of a hacking group. He used his security key to obtain physical access to the computer that controlled the heating, ventilation, and air conditioning (HVAC) for the firm using various methods, including password-cracking programs and a botnet, he rendered the HVAC system unstable ,eventually leading to a four-hour outage during trading time. The insider and his cyber conspirators were planning to use the firm's systems to conduct a distributed-denial-of-service (DDOS) attack against unknown targets.

Case Study 3: Theft of Intellectual Property

China sought to develop a next generation trading platform for brokers and dealers. China's state-owned Pangang conspired to steal the technology (design and code) developed by the US financial services company. A contractor (development manager) who had spent 15 years with that US Company used privileged position to help Pangang. The financial impact of this incident is estimated to be in the billions of dollars, and that does not factor in the consequent loss of competitive advantage for the firm.

Case Study 4: Espionage

A former senior financial analyst was arrested as he was boarding a flight for Switzerland carrying a large amount of sensitive customer data of high profile clients. Computers searched in his home led to the discovery of emails offering to sell secrets to Syria and China. He is thought to have been motivated not only by money (he had very heavy personal debts), but also by a sense of disgruntlement, as he complained frequently to former coworkers and neighbors about his job.

Scenario

Overview

Goliath National Bank (GNB) has developed and tested an electronic-trading system over the past 2 years, investing approximately \$30 million in the people, processes, and technologies to support a state-of-the-art e-trading system and challenge market leaders.

Recently, key components of GNB's trading algorithms have surfaced on the dark web. A GNB employee is suspected, but it's unknown how the infrastructure or data were compromised. In addition, the security operations center has disseminated several reports over the past few months indicating the financial industry is being targeted by sophisticated threat actors capable of employing blended attacks, including exploiting technical vulnerabilities and human intelligence sources. Senior management has identified the e-trading system as critical to the future of GNB and expressed concerns that the e-trading system has created opaque risk to the firm.

She then mailed the large volume of printed documents to a foreign embassy.

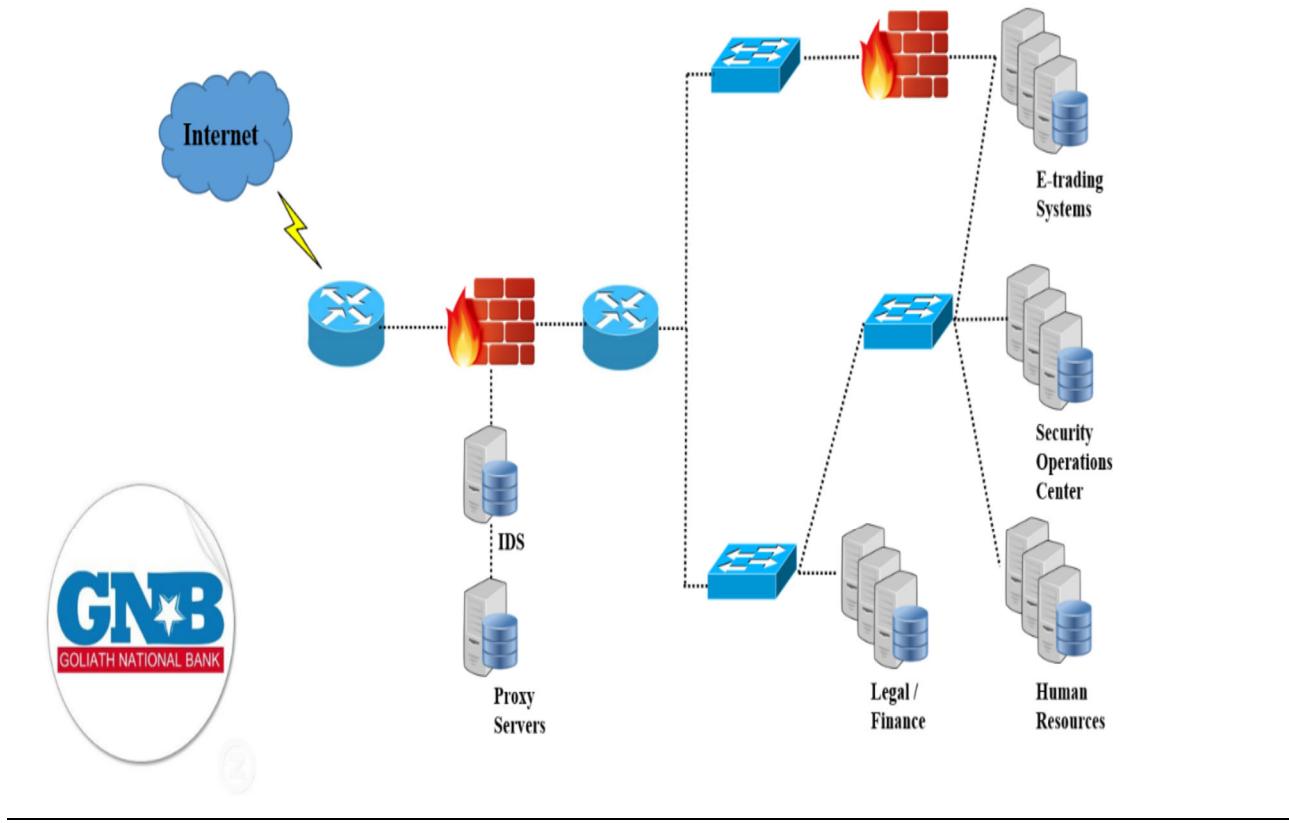

Mission

GNB's Information Risk Management teams will conduct a full risk assessment of the e-trading system. Information Risk Management teams consist of five functional groups across GNB, including Information Risk Officers, Behavioral Analysts, Cyber Threat Analysts, Compliance Analysts, and IT Risk Analysts. Groups will work together to conduct research, gather information, and leverage resources effectively to provide critical input and support individual team requirements. Risk assessments will identify the most critical people, processes, and technologies at GNB and help senior management make critical business decisions to appropriately manage risk at the firm. Identifying vulnerabilities, detecting current threats, protecting against threats, responding to compromises, and recovering operations is fundamental to sound IT Risk management.

Information Risk Management teams will provide senior management with a full risk assessment of the e-trading system and present a comprehensive insider threat management program leveraging industry guidance and best practices.

Project Role Profiles

During the semester-long team project, you will have a chance to play one of the following critical roles:

Behavioral Analyst, Junior

Demonstrates ability to understand human behavior involved in threat scenarios and is adept at applying psychological attributes that suggest vulnerabilities to an organization's people, processes, and technologies. Maintains an ability to analyze intruder exploit tools, identify and document the impact of resulting attacks and provide insight to team members based on such findings.

IT Risk Analyst, Junior

Demonstrates a basic understanding of information technology risk analysis. Understands the effects of various types of risks, such as potentially widespread Internet attacks, national security issues as they relate to their physical threats, financial threats, loss of business, reputation or customer confidence, and damage or loss of data.

Compliance Analyst, Junior

Communicates well with other team members with various levels of technical understanding in a written and oral manner. Background

Public health programs focus primarily on prevention and health promotion (rather than treatment), and on whole populations (rather than individuals). Public health is an essential component of the US health system. Its infrastructure and prevention-based programs, together with clinical health systems, work to improve population health and reduce health care costs among populations. The undergraduate program in public health at York College is focused on the science of protecting and improving the health and well-being of communities.

Reflecting the interdisciplinary approach of the CUNY School of Public Health, students in the major will take courses originating from the various public health core disciplines, including epidemiology, biostatistics, environmental and occupational health, and health management and policy. The community health concentration emphasizes specific training in the assessment, planning, implementation and evaluation of community-based, - focused and -driven public health programs and policies. Aligned with the Council on Education for Public Health (CEPH) accreditation criteria, the major curriculum is multidisciplinary while being rooted in the social and behavioral determinants of

health. As students progress through the program, they will gain more breadth and depth in public health practice through field experiences as well as a capstone course in their final year.

Upon completion of the degree, students will be better equipped to complete graduate education in public health or begin working in the field as a public health practitioner. Students will have acquired skills that could be translated into the workplace (city, state or local government agencies, non-for-profit organizations, etc.) or other post-baccalaureate educational settings such as enrollment in an MPH, MSW, JD or MD program.

Admission Criteria to the Program

At time of admission, a minimum cumulative GPA of 3.0 for all coursework completed; at least 12 credits with a minimum GPA of 3.0 in the following PH courses: PH 201 and PH 210 or PH 215 or PH 225 or PH 320 or PH 330 or PH 340.

Admission to the program will be based on a yearly cohort model of enrollment. A minimum of 33% of available program seats will be reserved for each of the following groups (given sufficient applications submitted): 1) Native York students; 2) Transfer students from CUNY; and 3) Transfer students from outside CUNY (e.g., 30 new program seats; 10 will be reserved for students from each group). Upon admission to the program (usually at the beginning of the third year in a 4year plan), students will be encouraged to attend full-time (if not already).

Retention and Completion Criteria

A minimum GPA of 3.0 in required program courses (including program electives); a minimum cumulative GPA of 3.0.

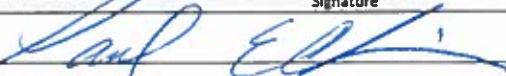

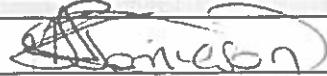

The entry level of the Occupational Therapy profession is the MS degree since mandated by the Accreditation Council of Occupational Therapy Educators (ACOTE) in 2007.

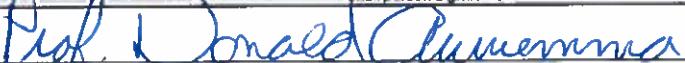

The first class of graduates to be comprised solely of combined BS/MS of Occupational Therapy students graduated in May 2007. ACOTE accredited the dual degree BS/ MS program in 2010. There are currently no students in the Occupational Therapy BS program (number 02918).

AI.1 Discontinuation of the BS in Occupational Therapy program

RESOLVED, that the program in Occupational Therapy leading to the BS degree at York College (program number 02918) be discontinued, effective April 2020.

EXPLANATION:

The combined BS/MS degree program obtained final approval from City University Board's Committee on Academic Policy, Program and Research (CAPP) in November of 2002. The first students of the dual degree BS/ MS program ($n = 14$) were admitted in September 2003. The stand-alone baccalaureate program in Occupational Therapy was phased out over a 4-year period. The final class of students receiving a baccalaureate degree with a major in Occupational Therapy graduated in May 2006.

The first class of graduates to be comprised solely of combined BS/MS of Occupational Therapy students graduated in May 2007. The Accreditation Council on Occupational Therapy Education (ACOTE) accredited the dual BS/MS program in 2010. There are no students currently enrolled in the baccalaureate program (BS) in Occupational Therapy (program 02918) .
