- a. Association Budget
  - -VP Lindow provided the report.

- VP Lindow passed a motion to allow Nicole Utley to become primary signatory and himself to be backup.

- The Halloween Party was a mess with fake blood and damage.
- VP Lindow explains better ways this could have been handled.
- He points out things such as covering sinks and padding walls.
  - i. IVP Claudio Lindow Clean Up Charges
- SGA must pay for overtime of workers to give the bathroom a deep clean and repair of the tile.

#### VIII. Old Business

- a. Club Council Committee
  - i. VP Williams notes that excellent observations were made at this committee. It needs better structure for the future but praises the committee for its work.
- b. Budget Committee
  - i. Calendar Structure
- VP Lindow and Dean Salnave explain how we must hold the clubs and us to deadlines. With Proposals and committees
  - Budget Committee explained
    - c. Athletics- Line-item Budget
- Dean Salnave and VP Williams explained at the last meeting we got a line-item budget of 139,472. It was approved on the condition that we get more details.
  - Breakdown of budget is looked at.
  - Concept of Bus rentals and allowing for more cost-effective ways for travel
- Dean Salnave makes a statement that we only got half of the request. We voted for half and now we have the second.
  - The total now is 292,000
- VP Lindow mentions transportation cost and getting a bus. Discussion on this continues. The goal is to get a vehicle which can make us profit.
  - Kerryann mentions the need for more than 1 vehicle for back up.
  - Item letter M from New Business (Athletics- \$153,425.00) moved up on list
  - Changes from the budgets were increased amounts no added items
  - Dean Salnave clarifies the first half was for winter and the new half includes Spring
  - Osa asks why it's so much more.
- Discussion on why that could be held. The consensus is that there are more sports in spring.
- Osayuwamen made a motion to approve the budget from last meeting while keeping proposal M pending until we have more questions answered.
  - Ella seconded

- d. OSA Budget Proposal \$99,500.00
- Budget will be to get the OSA through February. It is not full.
- Osayuwamen moves to approve.

- Dean Salnave asks for clarification on leadershape. 30-50 students are taken.
- Dean Salnave states that the body needs to be mindful of spending money and recommends a yearly budget be sent. VP Williams agrees.
- Voting Occurs

- Motion Passed
  - VP Williams stresses the need for full yearly statements moving forward.
- Discussion on people not submitted yearly budgets are explained. Context on how it affects the board and activities in school. Form A is discussed by IVP Lindow.

# IX. New Business

- a. Club Council Committee- Rule Implementation
- i. Clubs can only request up to \$3,000.00.
- Nelsy Explains how they voted for clubs to have a fixed amount to better control the money.
  - Dean asked how 3,000 dollars became the amount.
  - Nelsy explains it was based on previous clubs and minutes from last semester.
  - Dean Salnave clarifies that clubs will get 6,000 a year. (3,000 a semester) He asks if we can do that.
  - IVP Lindow asks how many clubs are active.
  - Nelsy explains we have 14 active clubs. Osa brings up the total amount used if we had 15 clubs would be 90,000.
  - Osayuwamen asks if spring clubs will only get 3000 since they were not active in the fall.
  - Dean clarifies that to be true but, Nelsy states that money can be allocated due to not all clubs using their expenses.
  - Dean explains that we need to be prepared for all clubs to ask for the full amount.
  - IVP Lindell suggests an itemized list for all clubs. Explains this process to Nelsy and the board.
  - 3,000 is the max more can't be asked for then that.
  - b. OSA Hispanic Heritage \$5,401.30

- Started in the president office. Assigned to Student activities.
- IVP Lindow asks what the money entails.
- Mrs. Skinner explains it's about the giveaways and events.
  - v. Senior Movie Day (\$2,200.00)
- Mrs. Skinner explains it's at the Jamaica multiplex. Private screening.
  - vi. Senior Sip and Paint (\$3,250.00)
  - vii. Senior Salute (\$1,000.00)
  - viii. . Senior Networking Brunch (\$4,700.00)
- Dean made a motion to allow the \$36,171.00 to be taken from the general fund to pay for the senior events.
- Ella seconded.

- VP Williams explained her concerns with safety and liability due to York Colleges named being attached to such a large event as a sponsor.
- VP Williams would like another discussion about risk management regarding this event.

Osa moves to approve the budget for ASA in the fall semester for 499 and 2,110,00.

# I. FYE mentor collective 44,722

Dean Salnave moved to pass the budget. The money coming from the general fund. Aurelie seconded.

- Dean Salnave explains we are currently in our 2<sup>nd</sup> year of a 3-year contract with this collective.
- Shayla Pruitt explained the program and told us last year 550 students have signed up.
- This is a program that could make returns and investments.
- Vote 9 YES 0 NO Motion passed.

# M. Athletics Budget \$153,425.00 (continued)

- Total budget now is 292,897
- Osa asked the difference between the original budget and the new updated one.
- Athletics explained that the \$139,000was what they were told they were allocated. This would allow them to get things up and running.
- The \$292,000 allows for them to properly run.
- There biggest cost changes are transportation, game officials, team meals, and medical equipment
- The budget last year is basically the same as last year.

They were allocated \$169,000 from association and an excess of \$100,000 from auxiliary plus 150,000 given to them \$50,000 and \$100,000.
